#### 9. UNFINISHED BUSINESS:

**A.** Administration – Consulting Services (Personnel). Discussion/Action (Board)

The Board will discuss negotiations with Paul H. Stein Consulting and direct staff accordingly.

The Board discussed specific work product examples, defined scope of contract and a timeline. After discussion and comments.

Motion was made by Director Bingham, seconded by Director Lorenz to put out the money for the contract with Paul H. Stein Consulting. Motion passed with three ayes and two noes, Conniry and Baker.

#### 10. NEW BUSINESS:

**A.** Election of Board Officers. Discussion/Action. (Board) The Board will elect officers and appoint representatives to the various

commissions and committees.

Director Lorenz nominated Director Conniry for President. Nomination passed unanimously.

Director Conniry nominated Director Lorenz for Vice President. Nomination passed unanimously.

District legal counsel Foster recommended that Directors receiving compensation for certain commissions and boards should abstain from voting on those items.

HTFA Commission lead representative Director Lorenz. Motion Passed with Director Lorenz abstaining.

HTFA Commission alternate representative Director Conniry. Motion Passed with Director Conniry abstaining.

HCFA Commission lead representative Director Conniry. Motion Passed with Director Conniry abstaining.

HCFA Commission alternate representative Director Baker. Motion Passed with Director Baker abstaining.

Motion was made by Director Lorenz, seconded by Director Baker to add Labor Negotiations – Fire Chief and have the President and Vice-Presidents be the ad-hoc committee Board representatives, currently Director Conniry and Director Lorenz respectively. Motion passed unanimously. Motion was made by Director Baker, seconded by Director Lorenz to update current committee and commission assignments' representatives as listed (see attached list). Motion carried unanimously.

Motion was made by Director Conniry, seconded by Director Liebig to form a new ad-hoc committee for retirement and replacement with Director Conniry and Director Lorenz as representatives and Director Baker as contingency alternate. Motion passed with four ayes and one abstain Director Baker.

**B.** Capital – Purchase of a Staff Vehicle. Discussion/Action (Chief/Board) Staff Recommendation: Approve the expenditure of an amount not to exceed \$65,000 for a new staff vehicle for the Fire Chief and to place the current vehicle into reserve status. Chief Laff reported on the collaborative partnership with the San Diego County Regional Fire Authority to obtain a significant savings in the purchase of this vehicle and to extend the time for the replacement of another vehicle for one more year.

Motion was made by Director Baker, seconded by Director Lorenz to approve the expenditure of an amount not to exceed \$65,000 for a new staff vehicle for the Fire Chief and to place the current vehicle into reserve status. Motion passed unanimously.

**C.** FAIRA call for nominations to the Authority Governing Board. Discussion/Action (Board)

The board had passed a motion to nominate Director Liebig to FAIRA on item 10A. On this item direction was given to staff to forward the necessary paperwork to FAIRA.
