- A. Resolution 15-002 Property Purchase. Discussion/Action. (Board) Attorney Sandra Brower was present and spoke on behalf of the Farida Family Trust opposing the Resolution of Necessity to acquire its property. District General Counsel Bohemer recommended the adoption of resolution 15-002. After discussion and comments. Motion was made by Director Baker, seconded by Director Bingham to Adopt resolution 15-002, resolution of necessity of the Lakeside Fire Protection District pertaining to the acquisition of certain property of interest in property and loss of goodwill pursuant to section 1263.510 of the code of civil procedure, if any, for use by the district in the development of a temporary or new Fire Station in compliance with the requirements of section 1245.230 of the code of civil procedure of the State of California. Motion Passed Unanimously.

(Board) Motion was made by Director Robeson, seconded by Director Bingham to authorize the contract renewal with Mr. George Tockstein to provide consulting services to the District for the purpose of assisting District staff in the management and oversight work in the building a Fire Station on Winter Gardens Boulevard in the Pepper Drive area of the District.  adopt resolution 15-005 a resolution of application by the Lakeside Fire
 Protection District Certifying a Categorical Exemption and Requesting the
 Local Agency Formation Commission Initiate Proceedings for the
 Proposed "CSA No. 115 Reorganization (Pepper Drive"). Motion Passed
 Unanimously.
