A. Resolution 15-007 Agreement with the Lakeside Firefighters Association. Discussion/Action (Board)

Staff recommendation: Adopt resolution 15-007.

After discussion and comments. Motion was made by Director Robeson, seconded by Director Bingham to approve staff recommendation, adopt resolution 15-007 which ratifies the Tentative Agreement reached with the Firefighters in April. The approximate cost of this agreement is \$137,000. The District will transfer this amount from the Emergency Reserve Funds into the General Fund to facilitate the prompt payment of funds to affected employees in the sincere hope that this payment will be made in the 2014/2015 fiscal year. Any funds at the end of the fiscal year 2014/15 reconciliation that are identified as surplus or non-allocated monies shall first be used to refund the Emergency Reserve Fund to replace monies transferred out to finance the Tentative Agreement as outlined in Resolution 15-007. Active employees of record in the affected group, employed as of April 7, 2015. Motion Passed Unanimously.

B. Presentation of Preliminary Budget. Discussion/No Action (Chief/Board). Staff recommendation: Accept the Preliminary Budget for review and continue the agenda item to the next regularly scheduled meeting on June 23, 2015 for adoption.
