The meeting was called to order by Director Conniry at 5:40 P.M.

#### 2. PLEDGE OF ALLEGIANCE AND INVOCATION

Director Lorenz led the Pledge of Allegiance and Lakeside Fire Protection District Chaplain Lloyd Dailey delivered an invocation and remembered former Division Chief Norman Lepker with a moment of silence.

#### 6. FINANCE

**A.** Resolution #13-017 fixing the employer's contribution under PEMHCA. Staff recommendation: Adopt resolution #13-017 fixing the employer's contribution under the Public Employees' Medical and Hospital Care Act.

District Legal Counsel Foster announced that Director Baker and Director Liebig recused themselves due to conflict. They left the board room at 5:46 for the discussion of this item. After discussion and comments.

Motion was made by Director Lorenz, seconded by Director Bingham to adopt Resolution 13-017 fixing the employer's contribution under the Public Employees' Medical and Hospital Care Act. Motion passed with three ayes with Director Baker and Director Liebig absent.

Director Baker and Director returned at 5:49 for the discussion of this item. Administrative Services Manager Schiwitz reported that the auditors gave an unqualified opinion. He thanked the Chiefs, Laura, Karen and Ashleigh. After discussion and comments.

Motion was made by Director Baker, seconded by Director Lorenz to accept the Audit Report for fiscal year ending June 30, 2013. Motion passed unanimously.

**A.** Paul H. Stein Consultant. Discussion(Board) Report on activities to date.

Director Lorenz reported he will be forwarding all information to board members for review.

**B.** Operations – Fire Station 1 Relocation. Discussion/Action (Board) Report on activities to-date.

Chief Parr reported that the item is more about funding than about the function of moving. Staff is currently working on establishing an end of useful life for the current facility. Awaiting the proposed LAFCO meeting.

**C.** Next Generation RCS Issues and Costs. Discussion/Action(Chief/Board) Report on activities to-date.

Chief Parr reported the next generation RCS agreement is forthcoming and a payment of \$600,000.00 fee will be due in 2015 with an additional 15% of other fees in the future.

**D.** Lakeside Fire Defense Foundation. A 501c3 Charity. Discussion/Action(Lorenz/Board

Chief Parr reported that a meeting has been scheduled with legal counsel to discuss Lakeside Fire Defense Foundation.

# 10. NEW BUSINESS:

**A.** Capital Expenditure – Fire Engine Purchase. Discussion/Action(Chief/Board)

Staff recommendation: Thank the apparatus committee for their diligent work and approve the purchase of a Smeal Type 1 Fire Apparatus Engine, (to be purchased using the County of Butte Specification and using pricing off of Butte County Purchase Order 67-12) with an amount not to exceed \$500,000.00.

Chief Laff reported that Captain Hisaw and Engineer Chiodo were in Nebraska doing an inspection. Director Baker thanked the apparatus committee for their diligent work. After discussion and comments.

Motion was made by Director Lorenz, seconded by Director Bingham to approve the purchase of a Smeal Type 1 Fire Apparatus Engine, (to be purchased using the County of Butte Specification and using pricing off of Butte County Purchase Order 67-12) with an amount not to exceed \$500,000.00. Motion passed unanimously.

**B.** UASI Grant Award for the Purchase of 800mhz Portable Radios. Discussion/Action(Chief/Board)

Staff recommendation: Purchase 14 APX 7000 radios in the amount of \$83, 394.08 and accept UASI Grant reimbursement in the amount of \$76,000.00 making the total cost for 14 portable radios \$7,394.08 coming from the Capital Fund.

Chief Laff reported that six radios have been tested at Station 3 with favorable reviews. After discussion and question and answer session. Motion was made by Director Bingham, seconded by Director Lorenz to Accept UASI Grant reimbursement in the amount of \$76,000.00 for the purchase of 800 mhz portable radios (14 APX 7000 radios in the amount of \$83,394.08). Motion passed unanimously.
