10. NEW BUSINESS:

A. Fire Code Adoption (Ordinance 13-001). Discussion/Action (Chief/Board) Staff Recommendation: Motion to waive a full reading of Ordinance 13-001 and conduct a second reading by title only and adopt Ordinance No. 13-001.

After discussion and comments the Board suggested presentation of the ordinance for review earlier in the cycle (summer of 2016).

Motion was made by Director Baker, seconded by Director Lorenz to waive a full reading of Ordinance 13-001 and conduct a second reading by title only and adopt Ordinance 13-001. Motion passed unanimously.

B. Board Policy Book – Policy Regarding District Firefighters Staffing Levels. Discussion/Action (Chief/Board)

Staff Recommendation: Receive proposed Policy 715 and bring this item back next meeting for further discussion.

The Board discussed the need for this policy and requested a budget forecast for direction. Director Lorenz made a motion to accept Policy 715 and Director Liebig seconded. After discussion and comments Director Lorenz withdrew his motion and Director Liebig withdrew his second. This item will be brought back at the next meeting for further discussion.

C. Resolution 13-018 - "A Resolution of the Board of Directors of the Lakeside Fire Protection District Approving and Adopting the Memorandum of Understanding (MOU) between the District and the Members of the Lakeside Firefighters' Association". Discussion/Action (Board)
Motion was made by Director Lorenz, seconded by Director Bingham to adopt resolution 13-018 approving and adopting the Memorandum of Understanding between the District and the members of the Lakeside Firefighters' Association. Motion passed unanimously.
